# PINE HOLLOW STABLES, LLC BARN RULES

Everyone who enjoys Pine Hollow Stables, all on property, boarders, riders, students, staff are subject to the stable rules and in addition to the terms and conditions of their respective boarding agreements they are subject to the following rules as may be amended and enforced from time to time at the stable's sole discretion.

<u>WAIVER AND RELEASE</u>: All visitors to Pine Hollow Stables including, guests, friends, and family, must sign a waiver and release form, even if they are not riding. Please submit your email address and we will email them to you so you can easily print them off at home, sign, and then drop in the payment box. Copies will also be available at the barn for unexpected visitors in the viewing room.

#### **SAFETY**

We are a helmet facility. When mounted on a horse an equestrian helmet should be fitted tightly and attached correctly. For safety reasons please see: <a href="https://animalscience.uconn.edu/equine/helmet-safety.php">https://animalscience.uconn.edu/equine/helmet-safety.php</a>

All children must be supervised. No running or yelling in the barn as this could spook a horse. Many children who ride have siblings who attend with them; those siblings must not create an unsafe environment for other riders so activities for spectators should include things that are quiet and not distracting to the horses or people in lessons.

Children challenging the barn rules will be asked by owner, manager, or staff to change behavior or asked to leave for the day. This is for children's safety as well as the riders.

#### HANDLING HORSES:

- a. When leading your horse from paddock or stall, assure halter and lead rope are securely fastened as are gates and stall doors. No walking horses without a lead. Grazing horses should be tied down by a post or body.
- b. No Riding in any stable aisle way or walkways.
- c. Horses turned out in the arena must be watched closely and kept from pawing or chewing on wood. Known cribber must wear a muzzle. Never chase a horse in the arenas as this disrupts the area footing. If a rider is ready to ride in arena TURN OUT HORSE MUST BE REMOVED IMMEDIATELY to another location by its trainer or rider. All manure must be cleaned after allowing horse in arena. Should these agreements not be respected then we will INFORCE A no arena turn out rule.
- d. Leaving horses tuned out and unsupervised is grounds for termination of boarding contract. Supervised turn out in arenas is allowed if no one is interested in riding or lunging in the arena. If a horse is ready to use the arena turned out horse must be returned to its stall.
- e. No Dogs other than Pine Hollow Stable residents.

<u>CLOTHING</u>: No Sandals, flip flops, crocs, or open toed shoes allowed in the aisles, arenas, paddocks, pasture or anywhere horses are present. If you do not have other shoes, and are unable to borrow some, you will not be able to go near the horses, even your own. When mounted closed toed footwear with a heel is the safest and will avoid a person's foot from slipping through a stirrup and hang up their leg resulting in the risk of being dragged by the horse.

<u>HOURS:</u> There are no set hours at PHS We only ask that when you leave the premise you observe rules all rules and recommend that you have a persona with you to call 911 in case of an emergency.

- f. No parking in/or blocking of walkways.
- g. No securing your horse in anything other than cross ties, hitch rails, arena posts or lead rope on rails or stall ties.
- h. Winter and ice are a huge safety concern when working with horses, to keep walkways clear of ice by not dumpling liquids or empting buckets in doorways or walkways. Buckets can be dumped behind barns.
- i. Anyone business working at Pine Hollow Stables LLC, is required to sign a separate working agreement as well as provide certificate of insurance listing Pine Hollow Stables LLC. Up to \$1,000,000.

#### 1. PERSONAL BELONGINGS AND PRIVACY

- a. Do not use other people's belongings without consent.
- b. The houses on property are PRIVATE PROPERTY. HOME on property is off limits except in case of an emergency. Do not enter or use the house for any reason. No one: including boarders, trainers, and students are allowed unless personally invited to join them.
- c. You may not handle, ride, and/or groom another boarder's horse without their permission.
- d. When going on vacation, and a friend or family member will be taking care of your horse, please notify the both the owner and manager in writing and provide emergency contact information.
- e. Pine Hollow is NOT a storage facility. Tack Lockers are available for rent. Belongings are to be kept in lockers or at home.
- f. To minimize the risk of personal belongings in vehicles being stolen or damaged, please take care to do the following: Lock vehicles, trailers, and lockers.

#### **CLEANLINESS**

- g. <u>CLEANING UP AFTER YOURSELF:</u> Cleaning up after yourself, your food, your drinks, tracking in mud and dirt, spilt items should be cleaned up immediately.
- h. The wash stall needs to be cleaned after each use to prevent clogging of the drain. All hair, mud, manure, and misc. debris in the drain must be swept and shoveled into a muck bucket. Standing water around wash bay or in aisle way needs to be swept into the drain. Shampoo and other items picked up off floor and put in container. Lastly, double check the hot and cold water is SHUT OFF completely.
- i. The wash stall needs to be cleaned after each use to prevent clogging of the drain. All hair, mud, manure, and misc. debris in the drain must be swept and shoveled into a muck bucket. Standing water around wash bay or in aisle way needs to be swept into the drain. Shampoo and other items picked up off floor and put in container. Lastly, double check the hot and cold water is SHUT OFF completely.
- j. All tack must be kept tidy and in tack lockers and off aisle ways and floors. Bridals, Halters, leads may be kept on stall hooks and blankets are allowed on blanket bars. Floor must be kept clear.

## KEEP TACK ROOM AND VIEWINGROOM DOORS SHUT AT ALL TIMES.

- k. <u>CLEANING UP AFTER YOUR HORSE:</u> IN AISLE WAYS, CROSS TIES, INDOOR AND OUTDOOR ARENAS, AND WASH BAYS. THERE IS CONFUSION what FULL CARE MEANS. Even if you are Full Care, Owners, Trainers, Students are required to clean all manure, horse clippings, hair, hoof clippings. <u>Including in the Indoor and OUTDOOR Arenas</u> of the horses they are working with. It is your responsibility to clean up your horse's manure in the arena EACH AND EVERY TIME even if it is a full care horse.
- I. Indoor semi self-care boarders must clean stall(s) at least every other day. If it becomes a noticeable problem, horse(s) may be required to be placed outside and there will be a **\$50** stall striping charge per horse. It is also suggested to worm own horse the first week of every even month.

## 2. **COMMUNICATION**

- a. Deana 515-208-9536 Pinehollowiowa@aol.com
- **b.** Memo board is for information only, broken equipment, and not for lecturing or complaining. If you have a complaint, please address it with Deana and she will resolve the matter.
- c. If your horse breaks something, please let us know as soon as possible so we can fix it.
- **d.** The barn has no set hours, however, remember that there are sleeping horses so use discretion and understand that there are many boarders who want to ride and use the arenas.

#### 3. EFFICENCY AND EQUIPMENT

- a. If you turn it on, turn it off, if you use something, put it back where it belongs.
- **b.** Last person in the barn turns the lights off in the barn, tack rooms and viewing rooms. Shut tack room and viewing room doors. In winter shut exterior doors.
- c. Take special care in the winter so pipes, hose and tack do not ruin in the elements.
- d. <u>Do not use hose inside of barns without owner's permission.</u> Should you break this rule, and cause damage to hose, hydrant, heaters etc., you will be required to pay for damages or repairs. **NO** EXCEPTIONS!
- **e.** Due to the nature of "farm" equipment and large animals that are on the property, (both in and out of fencing), we cannot take responsibility for any damages to horse, individuals or personal items that come up missing or are damaged or injured.
- **f.** In wintertime it is very important to close doors to keep barns as warm as possible.

#### **FEED AND SUPPLEMENT**

- a. Approximately 4 flakes of hay per horse/day when squares are being fed, or access to round bale. Due to the rising cost of hay, we ask that you do not feed extra hay or grain unless you are providing your own. If you feel that your horse needs more hay, and is on the thin side, please address this with Deana, and other arraignments can be made, however there may be an additional fee.
- b. Supplements may be given by PHS upon request. It is your responsibility to maintain the general health of your horse. Should PHS agree to dispersing supplements, they must be divided into daily servings marked with the horse's name and a.m. or p.m. and put in a container up off the floor attached to stall or in grain room.
- c. All customers who chose to provide grain must be stored in grain storage area, in only approved grain storage container to minimize rodent population and messes caused by other animals.
- d. All customers provided hay must be stored in storage arena above stall, not on floor at stall doors.

#### **FIRE SAFETY**

NO SMOKING on premises. (Four individuals have been grandfathered in and agree to only smoke at their vehicles parked in parking lot) Aisles, doorways, walkways, floors must remain clear of all combustible materials including but not limited to, grain, tack, treats and chemicals.

#### 4. HEALTH SAFETY

- a. MANURE CLEAN UP WILL BE ENFORCED as we get into good habits to prepare ourselves for NEW ARENA FOOTING! CLEANING UP HORSE MANURE IN AISLE WAYS, CROSS TIES, INDOOR AND OUTDOOR ARENAS, AND WASH BAYS IS THE RESPONSIBILITY OF THE RIDER, EVEN IF A STUDENT, THE TRAINER AND OWNERS.
- **b.** Getting the manure off of the footing ASAP
- c. Manure in the arena causes dust, indoor air quality problems, and allergens and we will be cracking down on boarders being responsible for their horse as we continue to improve Pine Hollow Stables, for its boarders and its guests. We want to make sure it is always at its best for you, and we need your help to do so.
- **d.** Students weighing more than 235 pounds will have to supply their own horses for lessons and will not be able to lease show or take lessons from the Pine Hollow Stables, LLC school horses. New horses being brought to the farm will undergo an introductory period before being introduced into the herd.
- e. Proof of fecal test results, rotational deworming **OR** a combination of the two methods (boarder provides empty tube, indicating worming has been completed, to management) will be done by boarder four times yearly: **Jan 1**<sup>st</sup>, **April 1**<sup>st</sup>, **July 1**<sup>st</sup> **and Oct 1**<sup>st</sup>.
- f. All horses must be vaccinated once a year for Rabies, Flu, and Tetanus, and COGGINS. Copy of vaccination must be emailed or delivered to Deana.
- g. Although we will come to the rescue of a cast horse or one we feel is in need of emergency care, (expectations to the rule) you and you alone are responsible for your horse's health so having a vet of choice on file with phone numbers and being responsive to calls in case of emergency.

#### 5. SECURITY

- a. Pine Hollow Stables is not responsible for lost, stolen or damaged property.
- b. For your horses/belongings safety and security please note on your stall door when you take your horse and /or trailer off the farm.
- c. For your horses/belongings safety and security please note on your stall door when your horse will be handled by someone other than you. (Vet Ferrier, Trainer, Family member, or Friend etc.).

- d. Do not put your horse in another person's stall without the owner's consent. When you have permission, please insure it is not at feeding to avoid mistakes and please leave the stall better than you found it, clean all manure, and top off the water bucket with water.
- e. Do not keep expensive tack at the barn unless it is locked in a tack locker or trailer.
- f. There are many like items, so be sure to MARK & LOCK ALL PERSONAL ITEMS
- g. Photos and VIDEO will be utilized on the property and agreement to this barn manual allows Pine Hollow Stables, LLC to use those images which may include but not limited to yourself, your friends, family, trainers and images may be used as desired for things including but not limited to marketing, social media, security and enforcement.

#### 6. PARKING

- a. Park only in designated areas away from animal traffic.
- b. Do not park on grass where animals may wander to graze.
- **c.** Do not block walkways or doors with personal vehicle at any time unless you are unloading grain, bedding, mats, etc. When finished, please move vehicle directly after.

# 7. ARENA RULES AND ETIQUETTE

- a. Be courteous to other riders when SHARING THE ARENAS.
- b. Communication is vital to a safe arena.
- c. When a lesson is going on the students will have the right of way for ½ of the arena.
- d. If there is someone riding who does not cantor or is having trouble with their horse, please stay at one end of the ring when you canter.
- e. Poles may be placed lengthwise on the short center line to split the arena and create a visual boundary. If you need to lunge and someone is in a lesson, ask "Where would be a good area to lunge my horse?" When horses are being lunged, they take up a lot of area with the lunge line and can make it very difficult for people to ride around.
- f. Please communicate with each other while riding.

- g. If you have a large pattern to work on, ex (barrels, jumping, testing, dressage) you may request lesson trainer and student, to allow you to do the pattern or reserve arena time in advance.
- h. Stop your horse and stand still whenever a rider is having trouble controlling their horse.
- i. DO NOT UNEXPECTILY STOP IN LINE OF TRAVEL OF ANOTHER RIDER OR IN FRONT OF ARENA DOORS, IF YOU NEED TO STOP/DISMOUNT DO SO IN THE CENTER OR CORNER OF THE ARENA.
- j. Trainers having lessons will allow others to enter area and communicate with students to share area. Large group lessons will require reserving the arena in advance so that Owner, manager, and staff can notify the barn boarders.

- k. When using jump standards, ground poles, trail equipment, please set up on the end of the arena so that others can ride around them and have room to ride on the other end. Some of the equipment may belong to other boarders; you need to have permission PRIOR to use of any equipment. All equipment needs to be put away in its correct place when you are done using it.
- I. We are all equal in the arena and we are all here to help one another. If you are unsure about anything, never be afraid to ask for help.
- m. When entering the indoor arena from any direction or entering barn through a roll top door, with or without a horse, be sure to announce your entrance WELL BEFORE you enter. Call out "DOOR", THEN LISTEN FOR A REPLY, and then it is okay to enter. If no reply, yell again and lift door a small amount and announce again. Riders inside the arena should either say OK or STOP wait a minute. Remember they don't know you are entering the arena and they might be riding by the same time you are entering.
- n. When riders are ready and waiting to use arenas, there will be a 1-hour limit for arenas.
- o. May have to share arenas when 4 riders in arena limit your riding to 1 hour per horse. When lessons are going on in the arena please try to work on the opposite side of the arena or in other arenas. Communicate with other riders if you need to do a pattern for jumping or dressage and limit to less than 3 minutes, calling out jumps. ARENAS MAY BE CLOSED FOR SPECIAL EVENTS SUCH AS CLINICS, CAMPS, OR SPECIAL EVENTS.

#### **SCHEDULING**

Group events must be requested in advance to reserve viewing room or arena time. Boarders will be made aware of these reservations through a social media messaging and information board communication system. A FEE MAY BE CHARGED.

I understand if I write a check that does not clear there is a <b>\$30 fee</b>
I understand if that happens more than once, I will be a <b>CASH-ONLY</b> boarder.
INTL *Under normal circumstances, Pine Hollow Stables, LLC require a 30-day notice of a boarder's intent to
terminate this agreement and remove horses from the premises. No partial refunds of fees paid. I agree to give a 30-
day notice or the equivalent in cash to exit the stables and agree that should I become more than 30 days late on board
payment, Pine Hollow has the right to do one or more of the following with my full understanding and consent. *Hold
